Dear IFSS Member

In accordance with Article C.5.1 of the IFSS By Laws, I have the pleasure of sending you the formal CALLINGNOTICE of the 2018 IFSS General Assembly.

According to this article, "The notice shall contain a request for any items which any Member may wish to have included on the agenda, to be sent to the President within six weeks before the meeting. The postage dates are valid." Such items should be in English. The six-week deadline date for agenda items to be sent to the President is March 29, 2018.

President and the Executive board shall require that motions for the General Assembly follow the Policy and Procedure for Motions to the GA. See pdf file: *Policy and Procedure for submitting Motions to IFSS General Assembly*.

In accordance with Article C.5.2 of the IFSS By Laws, the Draft Agenda will be sent to you before May 10, 2018, to enable you to formulate possible modification proposals by May 31, 2018 (Article C.5.3 of the By Laws).

I also remind you of Article C.7.3 of the IFSS By Laws: "For subsequent General Assemblies, said Voting Member may request a higher or a lower number of votes according to its number of participants. This request shall be approved by the Council if satisfactory documentation is presented to the Council at least 2 months before the General Assembly." In accordance with this By Law, if your participant number has changed since the last General Assembly, please present documentation of this change to IFSS Executive Director Dori Hollingsworth by April 14th, 2018, so that the Council can approve it.
